1	Minimum order value Express-PT: no minimum order quantity.
2	The DCC Proficiency tests are carried out according to EN ISO/IEC 17043.
3	Statistical evaluation: Statistical evaluation of the data is done on the basis of methods of robust statistics (Hampel estimator, Q-method, is defined in ISO/ TS 20612 (2007), DIN 38402-A45 (09-2013), DIN EN ISO/IEC 17043, ISO 5725 and DIN ISO 13528).
4	Ranking for the lab-performance: For the final assessment of the laboratory performance takes place a Zu-score calculation. With a result  Zu  ≤ to 2,04 the interlaboratory test is successful. Individual case decisions (Expert evaluation) reserve
5	Anonymity / Confidentiality: The interlaboratory tests are anonymous. Each laboratory gets an own changing labcode-number.
6	<b>Deadline for registration PT-Express:</b> The registration is possible throughout the year. (Please use order Email to order@dcc-germany.org)
7	Sample distribution/shipping Industries PT: The sample dispatch takes place throughout the year by DHL-Express within two business days.
