If the difference between the individual results is larger than the repeatability in the appropriate 12 standard method, a further double-test is accomplished. If applicable there is a statistically random selection of a representative number of test items from the whole batch in order to check the homogeneity of the material. The "bottle-to-bottle" variability for significant parameter will determined.
